## 20+1 Jahr Flüchtlinge in Brandenburg

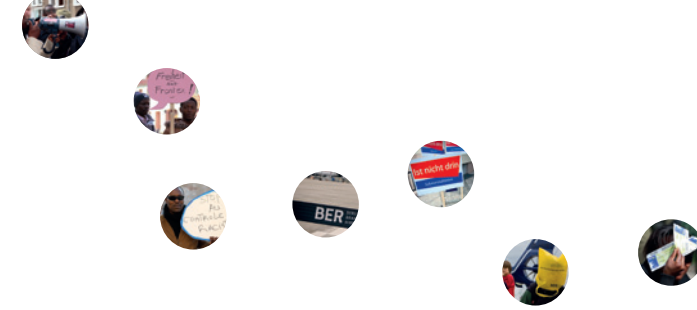
When the first refugees were »placed« in the new state of Brandenburg, an all-German racist campaign with the slogan »The boat is full« was already in full swing. In 1991, about 6,000 refugees arrived in Brandenburg and in 1992 the number was already 12,000. The Landkreise were not at all prepared to provide housing or any other support for the refugees. Most of them were »placed« in buildings that the Flüchtlingsrat later denounced as »jungle camps«. Refugees were not allowed to leave their assigned Landkreise and their children were denied schooling. Since 1993, they did not receive any cash allowance, only food from specially established warehouses. From the very beginning, local residents in many places tried to support the newcomers. But the general attitude of the people was skeptical or even hostile. Refugee camps and individual refugees were attacked, also in Brandenburg.

Over the last twenty years, things have changed. Europe closed its doors to refugees: By the end of 2010, only 3200 asylum seekers and »Geduldete« were living in Brandenburg. Many »jungle camps« have been closed for lack of occupants. After a long struggle, the »Residenzpflicht« for most refugees was extended to Brandenburg and Berlin since mid-2010. The warehouse supply system had been replaced by the still discriminatory vouchers. In the meantime

these vouchers were also discarded in most Landkreise. At present, only three Landkreise maintain a voucher system. Härtefallregelung and Kirchenasyl have successfully prevented deportation in several individual cases.

Although the federal government decides on the refugee policy, the localities influence how the policy is implemented. Therefore, the improvements in the living conditions of the refugees were and are always the results of the courageous commitments of a variety of initiatives, associations and refugee organizations. Their actions and perseverance have a decisive influence on the lives of refugees in Brandenburg.

Even though there have been some improvements, much remains the same and the time for vision is not over. »21 years of refugees in Brandenburg« is a good occasion to remind ourselves what has been achieved and to think about what still needs to be done. It is also an occasion to renew old contacts, establish new ones and make future plans.

### Accessibility:

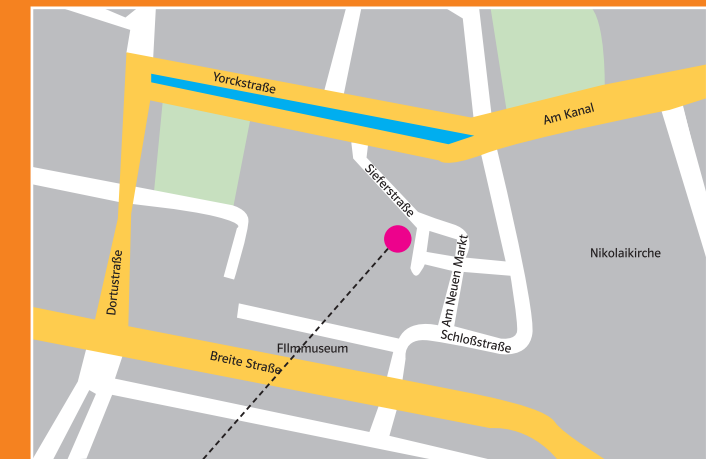
The Haus der Brandenburgisch-Preußischen Geschichte is wheelchair accessible.
